SHOOTING TIME / ADDITIONS: The videography and photography schedule and selected methodology are designed to accomplish the goals and wishes of the CLIENT in a manner enjoyed by all parties. CLIENT and GX Media agree that cheerful cooperation and punctuality are therefore essential to that purpose. Shooting commences at the scheduled start time.

FILM and COPYRIGHTS: The video footage and photographs produced by GX Media are protected by Federal Copyright Law (all rights reserved) and may not be reproduced in any manner without GX Media's explicitly written permission. **Limited** copyright ownership of the resulting footage and images will be transferred to the CLIENT under the following conditions:

The raw video footage, negatives and or slides are the property of CLIENT for personal use and for the purposes of the reproduction and giving of photographs to friends and relatives.

The Client must obtain written permission from and compensate GX Media prior to the CLIENT or its friends and relatives publishing or selling the photographs or video footage for profit.

EXHIBITION: Requests for specific negatives or slides to be used by GX Media may be requested at a future time. CLIENT grants GX Media permission to display selected images, video stills or video footage resulting from this assignment as an example of GX Media's Videography and Photography work and for entrance into photographic competitions and release all claims to profits that may arise from use of images.

MODEL RELEASE. The CLIENT hereby grants to GX Media and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases GX Media and its legal representatives and assigns from all claims and liability relating to said photographs and/or video footage.
